CONCURRENT ENROLLMENT AT OSU-OKC

WELCOME TO COLLEGE

Oklahoma State University – Oklahoma City welcomes you to participate in concurrent enrollment. We are so happy you are considering OSU-OKC as a partner in the beginning of your higher education experience! OSU-OKC's concurrent enrollment was designed with high quality and rigorous academic attention to create an engaging learning environment. We are committed to providing the best education to our students because we want to help you be successful and reach your educational goals.

BENEFITS OF CONCURRENT ENROLLMENT

Concurrent enrollment is an opportunity for juniors and seniors in high school to begin their college education before graduating from high school. Participating in concurrent enrollment not only will allow students to earn high school and college credit, but also will help students have a smooth transition to the rigor of college-level courses after graduating high school. Students are also encouraged to get involved on campus through Student Life to start creating college memories with new friends!

ADMISSIONS REQUIREMENTS

Students from Accredited High Schools:

Juniors and Seniors:

- Minimum ACT or Pre-ACT composite score of 19 **OR**
- Unweighted high school GPA of 3.0 or higher **OR**
- Minimum SAT or PSAT composite score of 900 (if taken before March 5, 2016) **OR**
- Minimum SAT or PSAT composite score of 980 (if taken after March 5, 2016)

Home Schooled Students or Students Attending an Unaccredited High School

Juniors and Seniors:

- Must have completed enough high school coursework to be equivalent to an individual who is classified as a junior or senior at an accredited high school **AND**
- Minimum ACT or Pre-ACT composite score of 19 **OR**
- Minimum SAT or PSAT composite score of 980 (if taken after March 5, 2016)

REQUIRED DOCUMENTS

All documents requested must be received before a student is accepted for concurrent enrollment.

OSU-OKC DOCUMENTS

- Application for Admission
 - Go to osuokc.edu/enroll and click "Apply Online" to complete our free application.

- High School Concurrent Enrollment Authorization form
 - This form must be completed and include signatures from either the principal or counselor **AND** one parent/guardian.
- High School/Proposed College Course Schedule
- Seniors only: Tuition Waiver Request form

ADDITIONAL DOCUMENTS

The following documents may be obtained from your high school counselor and/or your ACT/SAT account:

- Official (most recent) high school transcript
- Official ACT or SAT scores
 - Students may submit one residual ACT score taken at OSU-OKC per year (from November 1 to October 31) as a residual score is only valid at the institution at which it was administered.

COURSE PLACEMENT/ENROLLMENT ELIGIBILITY

Admission to OSU-OKC does not guarantee eligibility for course placement. To ensure students possess the skills necessary to be successful in college, concurrent students must demonstrate college readiness in a particular subject area to enroll in a corresponding subject area in college. In addition, students must demonstrate college readiness in reading to enroll in subjects outside of English, math and science. Concurrent students are prohibited from enrolling in any form of developmental education. College readiness is attained by achieving requisite subject scores on the following exams:

- ACT or Pre-ACT subscores must be ≥ 19
- SAT or PSAT subscores must be:
 - Writing & Reading ≥ 480
 - Math ≥ 530
- OSU-OKC Accuplacer scores must be:
 - Writing ≥ 98
 - Reading ≥ 80
 - Elementary Algebra ≥ 76 **OR**
 - College Level Math ≥ 44

Additionally, placement requirements for general education courses must be met.

COURSE ENROLLMENT LIMITS

High school students may not exceed a full-time college workload of 19 semester credit hours. For purposes of calculating workload, one half high school unit shall be equivalent to three semester credit hours of college work. Non-academic high school units are excluded from the workload calculation. Therefore, the combined high school and college courses taken in a given semester shall not exceed 6 classes.

Any student wishing to exceed the limits set by the Oklahoma State Regents for Higher Education must complete the *Petition for Excessive Hours (Academic Overload)* form.

COST TO ATTEND

Students are ultimately responsible for the costs incurred with attending courses. However, seniors are granted up to 6 hours of tuition waiver per semester. Seniors are still responsible for paying the associated fees incurred. All students must purchase their own books. Some school districts may pay for some of the tuition and fees and/or books. Check with your high school counselor for more information.

CONTINUED ENROLLMENT

To continue concurrent enrollment in following semesters, high school students concurrently enrolled in college courses must maintain a college cumulative GPA of 2.0 or above on a 4.0 scale. Students with GPA's below 2.0 are not eligible to enroll in college courses until after high school graduation.

Grades earned while in high school are posted to the OSU-OKC transcript and become a permanent part of the student's college record. Therefore, scholarships, grants, and other forms of financial aid (including Oklahoma's Promise) that depend on a GPA can be adversely affected if a student fails to maintain the appropriate GPA requirements.

TRANSFER OF CREDITS

Credits earned while in high school will count toward OSU-OKC degree programs and may also be transferred to other colleges and universities in Oklahoma.

RELEASE OF INFORMATION

Due to the Family Educational Rights and Privacy Act (FERPA), faculty and staff are not permitted to release any information about student records, including grades, to anyone other than the student unless written permission is on file. Students must complete a *Student Consent for Release of Educational Record Information* form to give this authorization to another person.
